The hidden cost of doing nothing with legacy email archives

When it comes to legacy email archives, many organisations are stuck in limbo. Systems like Mimecast, Enterprise Vault, and EMC SourceOne were once vital parts of the enterprise stack - but in the age of Microsoft 365 and Google Workspace, they're more often than not technical debt.

And yet, countless IT teams continue to "do nothing." The archive still works. The emails are still there. Migration sounds complex, expensive, and potentially disruptive. So they leave it for another year.

But inaction comes with a price; and it's usually far higher than anyone expects.

1. Ongoing costs, with diminishing returns

Licensing costs don't go away. Many legacy platforms charge per user, per archive, or per gigabyte. You're paying year after year to keep old data sitting on old systems, often on-premise or in hosted environments that don't align with your cloud-first strategy.

Storage costs, maintenance fees, and support contracts quietly accumulate in the background. And as infrastructure ages, the risk (and cost) of failure increases.

2. Compliance exposure grows over time

Regulatory frameworks like GDPR, FOI, and eDiscovery demands aren't static. As new rules emerge and legal expectations evolve, so does the risk of being caught out.

Legacy archives often lack modern compliance tooling. Defensible deletion, flexible retention policies, subject access requests, and searchability are all harder to achieve on outdated systems, especially if they're no longer receiving updates or security patches.

Doing nothing can mean falling out of compliance, simply because your platform can't keep up.

3. Operational inefficiencies compound

When archives aren't integrated into your core productivity suite, users suffer. HR needs to retrieve a leaver's mailbox. Legal needs access to historic correspondence. IT is called in to run legacy searches manually, export PSTs, or chase down credentials from long-retired services.
